RESOLUTION NO. 21-0400

RECOMMENDING THE USE OF RULE XVI SECTION 51 (REPEAT ORDER) MODE OF PROCUREMENT OF THE 2016 REVISED IRR OF RA 9184 AND AWARD OF CONTRACT FOR THE PROCUREMENT OF LAMINATED SACKS FOR THE USE OF REGIONAL RESOURCE OPERATIONS SECTION (RROS) OF THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FIELD OFFICE XII

WHEREAS, the DSWD Field Office XII thru its Bids and Awards Committee has received several Approved Purchase Requests of the REGIONAL RESOURCE OPERATIONS SECTION (RROS) under DISASTER RESPONSE MANAGEMENT DIVISION (DRMD) together with the Approved SPPMP;

WHEREAS, one of the functions of the Bids and Awards Committee is to recommend to the Head of the Procuring Entity (HOPE) the mode of procurement to be undertaken to meet the actual conditions and to ensure that the same is most advantageous to the government;

WHEREAS, the Bids and Awards Committee, through Section 51 – Repeat Order of Republic Act 9184 and its Implementing Rules and Regulations, intends to apply the sum of One Million Forty-Nine Thousand and Six Hundred Seventy Pesos Only (P1,049,670.00) to procure LAMINATED SACKS with Contract/Purchase Order No. 2020-10-0728 dated December 29, 2020;

WHEREAS, the procurement of the Laminated Sacks is needed for the Regional Resource Operations Section (RROS) stockpiling.

WHEREAS, CYN TRADING & SERVICES, INC. was previously awarded on 29 December 2020 as per figures in the table below under “Original Contract” through competitive bidding as follows:

WHEREAS, the unit price of the repeat order is the same as what was previously awarded through public bidding and is not the result of splitting of contract in accordance with Section 51.b and Section 54.1 of R.A. 9184 and its IRR;

WHEREAS, parallel to Sections 51.c and 51.d of R.A. 9184 and its IRR, the award was made within a six-month period and the quantity is not more than 25% of the quantity of items awarded in the original contract;

NOW, THEREFORE, in the consideration of the foregoing, WE, the Members of the Bids and Awards Committee, hereby RESOLVE AS IT HEREBY RESOLVED to:

1. Recommend to use the Repeat Order provision of RA 9184 for the procurement of additional LAMINATED SACKS of RROS intended for Stockpile;
2. Recommend the approval and award by the DSWD Field Office XII Head of the Procuring Entity (HOPE) of this Resolution and Purchase Order/Contract to CYN TRADING & SERVICES, INC. amounting to One Million Fifty-Nine Thousand and Six Hundred Seventy Pesos Only (P1,049,670.00).
