The Committee is expected to perform the following functions and responsibilities:

- Verify reports from the Secretariats and review if the SALN filed is submitted on time, uses the prescribed form and is complete;
- Render an opinion relative to an official or employee who failed to file their SALN, or who filed a SALN with incomplete data or is non-compliant with the Guidelines in Filling Out of the SALN Form issued by the CSC;
- Facilitate enforcement of the opinion rendered.

The functions and responsibilities of the Secretariat are as follows:

- 1. Receive SALNs of officials and employees on or before April 30 of every year;
- 2. Evaluate the SALNs and prepare reports of officials and employees who filed and those who did not file their SALNs;
- Submit endorsement of SALNs of the officials and employees to Ombudsman on or before June 31 of every year.

This order shall take effect immediately and shall continue to be in full force until revoked. All other order/s inconsistent with this are hereby amended and/or revoked.
