The requirement for a Certificate of Product Registration from FDA is only applicable to items 1 to 3, excluding tissue paper, which is considered a non-medical and non-food item falling outside the FDA's primary purview.</p>	<p>Note: (For lot 1 to Lot 5)</p> <p>* <u>Submit a sample of the items or products being offered along with the bidding documents.</u></p> <p>* <u>Items 1 to 3 must have a Certificate of Product Registration from the FDA.</u></p>
