Amendment to Invitation to Bid

For Item No. 2 – instead of the statement 'Delivery of the Goods is required by As per Schedule Set by the End-user upon the receipt of Purchase Order,' it should be 'Delivery of the Goods is within ten (10) working days upon receipt of the Purchase Order.'

2. The Department of Social Welfare and Development Field Office XII now invites bids for the above Procurement Project. Delivery of the Goods is within ten (10) working days upon receipt of the Purchase Order. Bidders should have completed, within Two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
