

Annual Accomplishment Report for CY 2018

I. Introduction

The Ambisyon Natin 2040 paved the way for the Field Office to ensure concrete and timely delivery of social welfare services for the poor, the vulnerable and the disadvantaged sectors.

This year involves series of activities pertaining to situation analysis, formulation of plans and review of sectoral program/plan implementation, monitoring and evaluation of the social protection programs of the department delivery of social welfare and development programs by Local Government Units through social welfare and development offices improved. All these accomplishment were influenced by the commitment of the entire staff who have committed to make things happen even amidst some difficulties.

As a government's response to community poverty challengess, the Pantawid Pamilyang Pilipino Program in Region XII continues to wrestle with the challenges of the implementation to achieve its objective of breaking the cyclical poverty situation among the poor. Pantawid Pamilyang Pilipino Program has lived up to the various challenges surmounting the program but the active involvement of the development partners, local government units, program partners, management office, and the program' work force has led to the achievement of the milestone accomplishments despite the odds.

It is therefore determined to continue promote and protect the rights and welfare of these disadvantaged and vulnerable sectors thru convergence efforts for a responsive and sustainable intervention to reduce poverty face by these sectors.

Continuing its technical assistance to LSWDOs thru the implementation of the approved 2018 Regional TARA plan that covers capability building, coaching and mentoring. These will enable LSWDOs improved SWD service delivery.

The proactive leadership in its initiatives along social protection through engagement with member agencies of the different regional inter-agency committees and follow-up technical sessions provided to LGUs just to ensure that the technology will be sustained once transferred to them and more importantly utilize it in local planning and budgeting process.

II. DSWD Core Programs



Pantawid Pamilyang Pilipino Program

As a government's response to community poverty problems, the Pantawid Pamilyang Pilipino Program in Region XII continues to wrestle with the challenges of the implementation to achieve its objective of breaking the cyclical poverty situation among the poor. Launched in 2008, the Project now covers 1,287 barangays in 45 municipalities and 6 cities (including Marawi City).

Furthermore, President Rodrigo Duterte directed the provision of Rice Subsidy/assistance to Pantawid Pamilya households as an additional grant in the amount of 600 per month to help the households meet their daily nutritional needs. Provision of Rice Subsidy is based also on compliance of the households either in education or health. This will be given during the regular payout period of the program along with the health and education grant of the beneficiaries.



Further, in response to the TRAIN LAW, a subsidy of Php 200 per month was given to the beneficiaries through the Unconditional Cash Transfer for assistance.

B. Household Coverage

As of December 2018, there are 220,238 households enrolled in the Regular Conditional Cash Transfer (RCCT) program including Marawi city (11,811) or 94.32% of the 233,507 sets 1-8 target beneficiaries determined by Central Office. Children aged 0-18 years old from these households totaled 500,715. While 22,558 or 98.59% enrolled in Modified Conditional Cash Transfer (MCCT).

There is a decrease of Pantawid households in RCCT from the previous report primarily due to delisted of Pantawid household beneficiaries with no eligible members for compliance monitoring and households with eligible children not in school or code 25, while the MCCT also have a decrease of households primarily due to double entry, not eligible, delisted due to registered in RCCT, and for no longer having eligible members for compliance monitoring.

Financial Accomplishments

Regular Conditional Cash Transfer

For the calendar year 2018, **98.70%** or **Php 4,255,393,700.00** total cash grants paid to compliant *Pantawid Pamilya beneficiaries* covering Period5 and Period6 of 2017 and Period1 to Period 4 of 2018 releases which consist of Php1,392,084,400.00 for education, Php 1,287,965,500.00 for health and Php 1,575,343,800.00 for rice subsidy.

The Pantawid Pamilyang Pilipino Program is consist of 3 systems, Beneficiary Data Management System, Compliance Verification System and Grievance Redress System which facilitates the updating or changes in the HH's data, monitoring of the compliance of the beneficiaries and receives and facilitate grievances. Series of activities are conducted through the 3 systems in 2018 program implementation. Below are the 2018 conducted activities:

Analysis: Out of 1,493 target Parent leaders only 1,152 or 77.16% parent leaders have attended the trainings because the remaining 224 participants are coming from North Cotabato and 57 from Sultan Kudarat a total of 281 Parent leaders. The main reason for the non-conduct was unavailability of venue and conflict time of the field implementers. So by the 1st quarter the training will resume.

Analysis:

The table shows that out of 23,712 target for updating only 21,614 are updated a total percentage of 91%.with the total 4,247 variances. The reasons for variances are as follows; Lacking Supporting documents (BC/MC), late submission of update forms. We advised the field implementers to lobby at LCR for mobile registration. To monitor the submission of the updating we obliged each staff to submit tracking report every Friday.



OVERVIEW OF REGIONAL ACCOMPLISHMENTS

SLP 2018's thrusts and priorities include the implementation with integrity, innovation and impact to the lives of the participants. With the new SLP guidelines under the MC 12; inclusion of non-pantawid as SLP participant was given an emphasis provided that he/she is included in the *Listahanan* database and tagged as poor, if not he/she must undergo the assessment thru the Household Assessment Form (HAF) or the SLP means test to determine if the certain household is poor.

Implementation of the backlog projects were prioritize that boosted the over-all regional accomplishment.

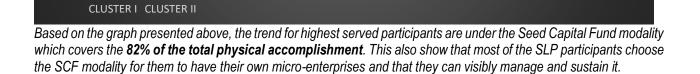

PARTNERSHIP ACCOMPLISHMENT/ INITIATIVES/ ENGAGEMENT

For government sector partnership, a Memorandum of Understanding between the DSWD-SLP RPMO XII and the Department of Agriculture under the Task Force Gatas was signed on November 22, 2018. The partnership aims on establishing a coo unity project of SLPA to have locally produced dairy products. See attached ANNEX 1 for the details of the government partnership for 2018.

For private sector partnership, partnership forum was conducted in the provinces of North Cotabato Cluster II and Sarangani and Gensan which aim to re-introduce the SLP and establish strong partnership between the private sectors in terms of packaging the SLP products, distribution and marketing. During the forum, a Memorandum of Understanding with the NEXT GEN Inc, HME Distributor and Tolentino Farms were also signed

KALAHI-CIDSS Project

The Region covers 10 active municipalities and 7 graduate municipalities for KC-NCDDP. These covers three of the four provinces in the region; Sarangani, Sultan Kudarat and North Cotabato.

Graduate municipalities are Lutayan, Senator Ninoy Aquino, Maasim, Maitum, Kiamba, Isulan and Bagumbayan

17 Municipalities are also covered by the Construction of Schools for IPs. KC-NCDDP and CCL coverage over-lap in many of the municipalities.

The Region also implements PAMANA IP CDD within two CADT. These are the CADT Erumanen Ne Menuvu and CADT Tinananon Manobo. As these are not bound by policital boundaries, these may only cover selected barangays in these municipalities. The coverage for the IP-CDD had been expanded to include additional CADTs. One CADT is formerly from the Region X but would be turned over to Region XII due to the overlapping nature of the CADT. There are also additional CADT Areas from South Cotabato, Cotabato Province and Sarangani Province.

All municipalities should have completed Cycle 4 implementation, except for Carmen. However, only Lutayan, Maitum and Kiamba have no remaining sub-project for implementation in 2019. The map below visually shows the coverage for Region XII.

Physical Accomplishment

The sub-projects are implemented under differing umbrellas within the Program. BUB are implemented by UNDP and IP schools are implemented by the volunteers under guidance of the different personnel hired under the umbrella of the Program. In case of KC-NCDDP areas, these sub-projects were implemented under guidance of the Area Coordinating Team. The 17 NCDDP Municipalities have implemented sub-projects mostly for the third and fourth cycle, along with some spill-overs from the second cycle, for NCDDP.

The sub-projects under the CCL are using the Government Procurement Act, with its more stringent requirements, and most of the sub-projects started well behind the target date. However, accomplishment in the area is more than is reflected in the Geotagging WebApp earlier in the year. Issues in encoding arose as a result of the non-payment of salaries of CCL staff since January 2018. Though there are declared completed SPs, there is not enough data at the regional level to encode and save the SP Profile. To date, the region had encountered eight (8) 8888 complaints and two walk-in complaints from the barangays on the CCL in under two months. The non-payment of salaries and wages of CCL staff affected implementation, SPI is at a stand-still and monitoring is nil. The management is concerned about the remaining funds in the BLGU accounts considering that there is no staff stringently monitoring the status of the funds in the barangay accounts. CCL staff had received their salaries from January to June 2018. However, the last "kinsena" are on hold for those who had resigned prior to the completion of the clearance from the Regional Office. This is to make sure that staff are cleared of all accountabilities. There are only a few, three, remaining CCL staff by the end of 2018.

For IP-CDD, prioritization had been conducted and Requests for Fund Release had been submitted for the first cycle. Submission and encoding were also affected by the delayed payment of salaries of the staff. All of their SPs were encoded into the Geotagging Webapp only in December. Informal training on the different KC PIMS platforms is to be given to staff, many of which are replacement of staff who decided to resign or did not renew their contract. The PAMANA Regional Staff strategized and used a meeting to encode the first cycle sub-projects under IP-CDD last December 2018. The process was a plenary demonstration and explanation followed by the hands-on for the Geotagging WebApp and Online PIMS Platforms. Owing to the differences in the skills and understanding of the PIMS from the different



personnel, the activity was done with close-in coaching by the three M&Es. There were also issues encountered in the encoding, the M&E Unit coordinated with the NPMO and requested real-time technical assistance with the NPMO M&E especially those under the database.



National Household Targeting System

By virtue of Section 82 of RA 10963 or the Tax Reforms for Acceleration and Inclusion (TRAIN) mandates the DSWD to implement the Unconditional Cash Transfer (UCT) Program. The UCT Program provides cash grants to offset the increase in prices of goods for those who will not directly benefit in the lowering of personal income taxes. The target beneficiaries of UCT are Pantawid Pamilya Pilipino Program, Social Pension and Listahanan 2 households in the first and seventh income deciles.

Pursuant with the above, NHTU field offices attended an orientation on the Train law last February 05-07, 2018 at the DSWD Central Office. It was during that time that the NHTO issued a directive to conduct the validation of potential UCT beneficiaries in all regions.

NHTU ARMM LaMa has the following accomplishments anent to this:

- The RFC, RITO and SMO together with the OIC PPD Chief visited the new secretary of DSWD ARMM, Atty. Laisa M. Alamia on February 13, 2018 to discuss with her the said validation of potential UCT beneficiaries in Lanao del Sur and Maguindanao. The Secretary had approved and expressed her support of the said activity and designated Assistant Secretary for Operations (Asseco) Pombaen K. Kader as the point person in terms of UCT validation.
- Orientation with the P/C/MSWDO and the Provincial Links was conducted with the DSWD ARMM immediately on February 15 and 19, 2018 and discuss with them the guidelines of UCT-Listahanan Validation, the selection and screening process of field staff. In the screening and selection of field staff for the validation, it was agreed that the PSWDOs of Lanao del Sur and Maguindanao will receive the documents of applicants of every municipalities. The PSWDOs will shortlist the applicants based on the documents they received. The shortlist of the PSWDOs will be the applicants to be subjected for joint selection by the region and DSWD ARMM.



- The office together with the representatives of DSWD ARMM conducted a joint selection of the applicants on March 06 to 09, 2018. the NHTU Field Office together with the DSWD ARMM had conducted a joint selection of the field staff to be hired for the validation of potential UCT beneficiaries in ARMM LaMa. The result was released and communicated with the DSWD ARMM.
- The training for the validators and administrative aides was conducted last March 20-23; March 26-28 and April 03, 208. There were 3 batches for the staff to be deployed in Lanao del Sur and 3 also for Maguindanao. The training of field staff to be assigned in Marawi was conducted in April 03, 2018. Every after the orientation, the field staff was deployed in their respective areas of assignment.
- A monitoring team was created to oversee the operations in ARMM LaMa. It was composed of the staff of the Policy and Plans Division such as the OIC PPD Chief, the Regional Field Coordinator, the Regional Information Technology Officer, the Social Marketing Officer, the Administrative Assistant III and the Project Development Officer III of Standards Unit. Every staff was assigned with areas to monitor and oversee the operation. All the issues relating to the field will be handled by the monitor such as the courtesy call to the LGUs and BLGUs, reconnaissance of the areas, the house to house activity and all other issues relating to the validation. The overall monitor of the two provinces was the RFC.
- The actual house to house visit for the validation of potential UCT beneficiaries in Lanao del Sur and Maguindanao provinces started in April 01, 2018 and was completed on May 15, 2018. A total of 860 field staff were hired but only 764 of them continued and completed the validation.
- The target for validation in these two provinces totalled to 233, 418 households. 120, 847 target households for Lanao del Sur while 112, 571 for Maguindanao. A total of 195,950 or 84% from the target was validated the 15% were not validated due to no qualified respondent, presence of disaster or peace and order problem, pantawid beneficiaries and other reasons relative herein. (*Refer to Table 1*)The summary is shown in the table below.

 June 29 until the 1st week of July was the releasing of Salaries of Field Staff while the remaining travelling expense of the field staff was released on the 1st week of October. All their claims relating to the validation were released in October 2018.

Listahanan 2 Data Sharing

A consultation with the LSWDO of ARMM LaMa on the Data Sharing was conducted by the NHTO in General Santos City on November 15-16, 2018. 67 participants from the LSWDO of ARMM LaMa had attended and participated the activity; 34 from Lanao del Sur while 33 for Maguindanao. The main objective of this activity was to determine the hurdle of the data sharing activity of these regions. The output of the workshop will be used as reference for the implementation of Listahanan 3.

III. PROGRAMS / PROJECTS WITH IMPLEMENTATION SUPPORT FROM LGUs



Twice-a-day Feeding CY 2017 in Partnership with 21 LGU.

LGU Arakan, North Cotabato is now on their 91 feeding days serving 1,925 or 101% children beneficiaries from 88 Child Development Centers.

Supplementary Feeding Program (SFP) CY 2018 in partnership with LGUs

Among 49 LGUs who received the augmentation support on Supplementary Feeding Program, forty-three (43) of these have on going implementation serving **92,035** children beneficiaries or **97%** accomplished. The feeding is being catered by **2,670 Child Development Centers and 281 Supervised Neighborhood Play**. There are still seven (7) LGUs that have not yet started the actual feeding. LGUs President Quirino, Isulan, Antipas, Banisilan and Alabel are still in the procurement stage while the LGU Arakan and Makilala are waiting for their supplier to deliver their goods. The delay was caused by bidding process. They are expected to implement the feeding before the year ends.

For this month, a total of **Php 69,715,648.00** were utilized by 43 LGUs or **48.96** % accomplished out of **Php 142,390,680.00** total allocation of the LGUs.





Social Pension Program for Indigent Senior Citizens

Below are the data of senior citizens in the region registered at the OSCA for CY 2018. In the right side of each province is the total number of Social Pensioners of the National Government through DSWD FO. We can see that there are 75, 943 senior citizens not covered by the program because they are not qualified based on the eligibility of the program. Disaster Response Operations

Region XII and ARMM areas has always been in the lamplight of major natural and manmade disaster. In terms of natural hazards, the region is prone or susceptible to landslide, flooding, earthquake, tornado, tsunami, drought and volcanic eruption. While on human-induced disasters these includes fire or conflagration and armed conflict due to ideology, tribal or clan wars, and land dispute. Region XII have two volcano classified by PHIVOLCS as active. In the region, there are 2 active volcanoes identified and monitored by PHIVOLCS, the Mt. Matutum (2,286m) located in the tri boundaries of South Cotabato, Sultan Kudarat and Sarangani, and Mt. Parker which is located in the Municipality of T'boli, South Cotabato. Other than that, there is also one active volcano the Mt. Ragang that post a threat to the region, though it is located in ARMM area boundary of North Cotabato but history showed its devastating effect to Region XII. Latest risk assessment report conducted in the region by DENR-MGB XII indicates that out of the 1,194 total number of barangays, there are 341 barangays that are highly at risk to flooding, 218 barangays to landslide, and 75 barangays to tsunami in Region XII.

Disaster Response and Management Division (DRMD) of the Department of Social Welfare and Development aims to continuous and to ensure timely, effective and coordinated to provide Technical Assistance and Resource Augmentation (TARA) to the affected areas or local government units in Region XII and some part of ARMM areas of all natural and manmade disasters/calamities.

PREPAREDNESS FOR RESPONSE:

For the year 2018, part of the preparedness activities conducted by the DRMD is to capacitate not only our partners LGUs but also our Quick Response Team (QRT) members on how to be equipped and respond effectively and efficiently to any disaster or crisis that may occur not only in Region



XII but to other regions as well thru trainings. We have conducted three

(3) Trainings for QRT member such as: Basic Incident Command System (ICS) Course to 33 Quick Response Team (QRT) last November 7-9, 2018 @ General Santosc City, Emergency First Aid Training and BLS-CPR with AED for Lay Rescuer to 25 Quick Response Team (QRT) last December 11-13, 2018 @ General Santosc City, Critical Incident Stress Debriefing (CISD) to 36 Quick Response Team (QRT) last December 17-19, 2018 @ General Santosc City, 3 days Training on Camp Coordination and Camp Management (CCAM) to Local Government Unit of Polomolok, South Cotabato last September 19-21, 2018 at London Beach, General Santos City.

One Hundred (100) Quick Response Team (QRT) were already trained on the different Disaster related training.

DISASTER RESPONSE OPERATION MANAGEMENT AND INFORMATION CENTER (DROMIC)

The Disaster Response Assistance Operations Management & Information Center (DROMIC) unit had reported 32 disaster incidents (13 Natural Disaster & 19 Man-made Disaster) in Region XII and Maguindanao areas that includes Flashflood, Big waves, Armed Conflict, Bomb Explosions, and Fire with a total number of 46,553 affected families or 225,818 persons.

Early Recovery and Rehabilitation

As part of the early recovery and rehabilitation assistance, 280 beneficiaries/affected families due to flash flood and strong surge whose house were totally and partially damaged received the10 days Cash for Work and Emergency Shelter assistance. The provision of emergency "self-build "shelter assistance through limited materials or financial assistance to augment resources of affected families who opted not to be transferred to a resettlement site to enable them to purchase shelter materials required in constructing or repairing damaged houses which were partially or totally destroyed in Kalamansig Sultan Kudarat. A total of Php 4,205,615.00 provided/extended to the victims.

DISASTER RESPONSE

As the lead agency for the Response and expected to provide leadership and coordination, readily mobilize and deliver resources and as the frontline for the delivery of disaster response to the affected families and as an augmentation to LGUs, the DSWD XII spent Twenty Five Million FIfty Three Thousand Eight Hundred Eighty Six Pesos (P25,053,886.00) in relief assistance (food and non-food, financial assistance).

AUGMENTATION TO MARAWI SIEGE:

On May 23, 2017, armed conflict transpired between Armed Forces of the Philippines (AFP) and the Maute Group/ISIS. After the President, His Excellency Rodrigo R. Duterte declared the liberation of Marawi City on 17 October 2017, the return of the displaced families has commenced and thus starting the Kambalingan Program for the Returning Marawi City IDPs of the Department. The region continuous serving the affected families. As of December 31, 2018, a total of 621 families are still staying inside evacuation centers in different municipalities of Lanao del Sur, while in Region XII we have 242 displaced families staying with their relatives. A total of 46,050 or 82% percent of the 56,449 total projected number of displaced families for "Kambalingan" in the 72 barangays have been served.

Centers and Institutions

Regional Rehabilitation Center for Youth

The **Groundbreaking Ceremony** for the construction of New RRCY Building in a 5000 SQM lot donated by BLGU of Bukay Pait, Tantangan, South Cotabato was successfully done on October 30, 2018. The event has been remarkable in this 4th Quarter of 2018 that finally, the construction of **Two Story RRCY Building for Residents Quarter with an estimated bed capacity of 60,** Administrative Building, Covered Court, Power House and Parameter Fence are now on going and expected to be operated in the first semester of 2019. Likewise, the repair of kitchen/dining room at the rented facility in Koronadal City is now operated and utilized by the residents.

Further, the joint celebration of Children's Month in cooperation and collaboration with Regional Office Children and Youth Sector Focal, Ms. Johanisa M. Simbangan, SWO II with the all out support of four (4) Centers and Institutions such as RRCY, RSCC, Home for the Girls and Women and Center for the Handicapped has been successfully celebrated last November 30, 2018 at Eighty-

Eight Hotel. Aside from it weekly scheduled activities such Solo and Duet Singing Contest and Dance Contest held the Regional Office covered court. The highlights of the activities are the **Search on Kabataang Pinoy** as such, the RRCY & RSCC residents have crowned at the first ever **KABATAAN PINOY 2018.**

SUMMARY OF CASES SERVED

The center had fast tract the speedy disposition of client cases. A total number of **28 residents were cases served** coming from different provinces, cities and municipalities under the jurisdiction of Region XII. Twenty-four (26) are carried over from third quarter of 2018 and Two (2) are **new admitted** this 4th quarter. Likewise, **5 cases** had been favorably dismissed by court thru amicable settlement with their private complainants and **1** is granted for Release on Recognizance and awaiting for discharge.

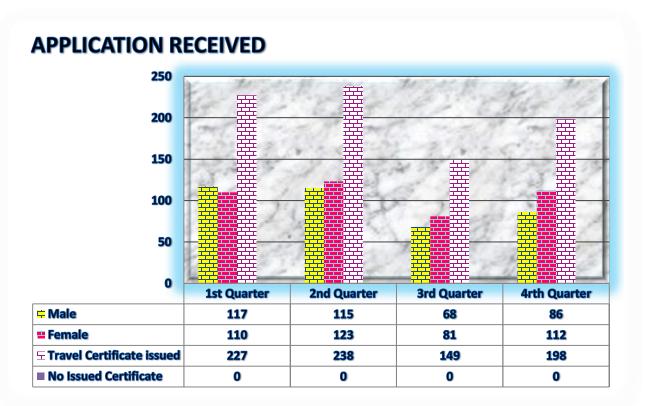

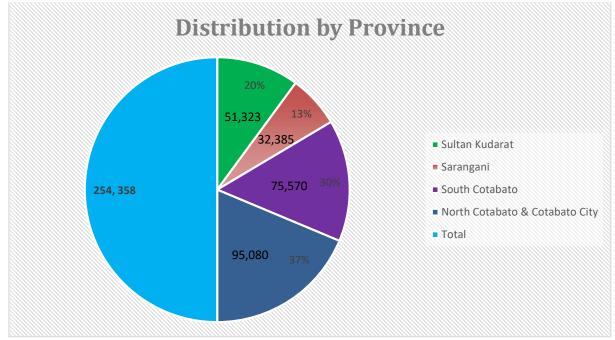

WOMEN & FAMILY

Advocacy Activities during Women's Month

The PCW Board Members and Inter-Agency Technical Working Group identified the NWMC theme **"We Make Change Work for Women"**, which shall be used from 2017-2022. **It highlights the empowerment of women as active contributors to and claimholders of development.** This pursuit of development is also anchored on the commitment of "Malasakit at Pagbabago" or True Compassion and Real Change.

The students were placed in sections needing most assistance from the students and where the students can complement their formal learnings with the hands-on experience that they would have in the sections/units.

Prior to their placement, students had to comply with the requirements followed by an orientation on the programs and services of the DSWD, expected roles of each student, attendance, and other matters discussed by Student Training Program Focal Person.

V. Standards Unit

For the year 2018, the Standards Unit have smoothly accomplished its target geared towards the regulatory function of the department. We have monitored twenty eight (28) SWDA's and provided technical assistance on the five areas such as Administration and Organization; Program Management; Case Management; Helping Interventions; and Physical Structure and Safety. Issued DSWD registration to two (2) SWDA and Registration and License to operate to eight (8) Social Welfare Agencies. Standards Unit were able to assist the Standards Bureau for the accreditation of fourteen (14) SWA and had endorsed three (3) LGU Run center; eight (8) Senior Citizen Centers; and six (6) Social Workers Managing Court Related Cases. We had also exceeded 41% of our target in the accreditation of Day Care Center/ Day Care Workers with 212 accomplishment versus the 150 target. Alongside with 31 accredited Pre-marriage Counselors and one SWDA that was issued with a Solicitation permit.

On the CSO accreditation, we have validated two (2) implementing agency and issued Certificate of Accreditation to 410 CSO beneficiaries after complying with the requirement and passed the



deliberation of the Field Office-Accreditation Committee (FO-AC).

Further, the five clusters ABSNET as well as the Regional ABSNET Federation continues to help the Standards Unit in monitoring the SWDA's as well as conducting activities for the welfare of the clients they served.
